APPLICATION FOR OUT OF STATE TUITION DIFFERENTIAL WAIVER
NON-RESIDENT STUDENT – Under 24- INTERNATIONAL (U.S. Parent/Guardian)

As of the first day of classes for the term, a Non-Resident Student waiver may be granted to a non-citizen **student under the age of 24** whose parent or U.S. court-appointed legal guardian has maintained domicile in Georgia for at least 12 consecutive months preceding the first day of class. The student must provide clear and legal evidence showing the relationship to the parent or United States court-appointed guardian has existed for at least twelve (12) consecutive months preceding the first day of classes for the term. Under Georgia code, legal guardianship must be established prior to the student's 18th birthday (BOR Minutes, October 2008). The student may retain the waiver every semester after the waiver is approved provided the student remains continuously enrolled. If a student does not register for a Fall or Spring semester following their last enrolled semester at KSU the waiver will be removed. If the student returns to KSU, the student can reapply for the petition if they are still eligible or petition to change their tuition classification if they are eligible. I understand that any material false statement made knowingly and willingly by me on this application, or any documents attached hereto may, in accordance with O.C.G.A. 16-10-71, which provides that upon conviction, a person who knowingly commits the offense of false swearing shall be punished by a fine of not more than \$1,000 or by imprisonment for not less than one nor more than five years, or both, subject me to prosecution in a court of law. Additionally, I further understand that any such false statement may subject me to immediate dismissal from the institution.

I understand this waiver, if approved, will remain on my account every semester I enroll provided I stay continuously enrolled at KSU. If I do not enroll for a Fall or Spring semester immediately after my last enrolled semester, my waiver will be removed
